G.S.R. 411(E).—In exercise of the powers conferred by sub-sections (1) and (2) of section 469 of the Companies Act, 2013 (18 of 2013), the Central Government hereby makes the following rules further to amend the **Companies (Incorporation)** Rules, 2014, namely:—

- 1. **Short title and Commencement.**—(1) These rules may be called the **Companies (Incorporation)** Sixth Amendment Rules, 2019.
 - (2) They shall come into force with effect from 15th August, 2019.
- 2. In the Companies (Incorporation) Rules, 2014 (herein after referred to as the said rules), in rule 19,—
- (i) in sub-rule (1), for the words, letters and figures "Form No.INC.12", the words, letters and figures "Form INC-32 (SPICe)" shall be substituted.
- (ii) in sub-rule (3),

- (a) in clause (a), for the words "the draft memorandum", the words "the memorandum" shall be substituted;

- 3. In the Annexure to the said rules,—
- (i) in Form no.INC-11, in the heading, after the words and figures "sub-section (2) of section 7", the words and figures "and sub-section (1) of section 8" shall be inserted.
