About the Survey


- CimplyFive conducted a short survey for a focus group of our CAIRR users in **July 2018**.

- The highlights of this survey are documented in this report.






CAIRR Survey: Respondents' Profile


Qualification




Current engagement




Age Group






CAIRR Survey: Responses


- Usage: 70% of the CAIRR subscribers visit the site regularly - daily(40%) or weekly(30%).

Why do you visit www.ca2013.com?






CAIRR Survey: Responses


- Utility: 60% of the participants said that most of their needs are met, in addition 19% said all their needs are met.
- Credibility: 74% of the participants completely rely on the site without looking for any other authentication.

Do you trust the information in www.ca2013.com?



CAIRR Survey: Responses

- Promoters: 59% gave a score of 9 or 10 when asked, “How likely are you to recommend www.ca2013.com to a friend or a colleague?”
- Net Promoter score (NPS) = $58.8 - 15.7 = 43$
- Bain & Co (inventor of the NPS system) suggests a score of 50 to 80 is typically considered very good or even outstanding. A score around 30–50 is universally seen as good, and anything above 20 is favourable.
