# Subject: Filing of Announcements pertaining to Loss of Share Certificate/Issue of Duplicate Share Certificate/Closure of Trading Window and Corporate Insolvency Resolution Process ('CIRP') in XBRL format on NSE Electronic Application Processing System (NEAPS) platform.

Further to the various Exchange circulars (Circular Ref No: NSE/CML/2023/34 dated May 15, 2023, Circular Ref No: NSE/CML/2023/28 dated March 31, 2023, Circular Ref No: NSE/CML/2023/11 dated January 27, 2023) issued for filing of equity announcement in XBRL mode and other circulars seeking comments/feedback from listed entities on the captioned events (Circular Ref No: NSE/CML/2023/40 dated June 14, 2023 and NSE/CML/2023/41 dated June 21, 2023), kindly note the facility for filings disclosures intimating the following announcements under SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI LODR') will be made available in XBRL format with effect from December 09, 2023 ('effective date')

- 1) Loss of Share Certificate/Issue of Duplicate Share Certificate
- 2) Closure of Trading Window
- 3) Corporate Insolvency Resolution Process

At the initial stage, the PDF filings will be considered by the Exchange as compliance under Regulation 30 of the SEBI LODR. Further, all listed entities would be required to also submit the filings in XBRL mode within 24 hours of submission of the said PDF filing. At a later stage (date to be informed separately) Exchange will shift to only XBRL submission.

It may be noted that, XBRL utility for the above-mentioned subjects is available at the path COMPLIANCE >> Common XBRL Upload >> Equity Announcement- XBRL, basis the selection of the 'Subject of Announcement'.

Further, it may be noted that the aforesaid three events, will be made available in iXBRL format to the listed entities and it will be made available to the listed entities at the path Report >> Announcement XBRL Report

iXBRL or Inline XBRL, is an open standard that enables a single document to provide both human-readable and structured, machine-readable data.

iXBRL takes the HTML standard that is used to power the world's web pages and embeds extra "tags" into it that give meaning to the figures and statements in a format that can be understood by a computer.


